### **AVAILABILITY**

Available for any type of Large Power use at any point within the Cooperative's certified area requiring in excess of 100 kW of measured demand, supplied at one point of delivery and measured through one time of use rated kilowatt-hour meter and subject to the Terms and Conditions of Service established by the Cooperative. To be served from this rate member must limit on peak demand to no more than one half of the monthly off peak demand.

## TYPE OF SERVICE

Three-phase, where available, 60 Hertz, at one standard delivery voltage. Single-phase motors shall be limited in size such that starting current does not exceed 260 amps at 230 volts. Motors greater than 60HP must be coordinated with Seller prior to installation.

### RATE

Monthly Charge

Demand Charge: On Peak Demand:

\$11.31 per kW of On Peak demand

Off Peak Demand:

\$4.93 per kW of Off Peak demand

All kWh per month

\$0.062 per kWh

The charges for On Peak demand and Off Peak demand will be compared to arrive at the total demand charge for the month. The larger of the On Peak demand charge or the Off Peak demand charge will be added to the monthly charge and the kWh energy charge to arrive at the net calculated bill.

## MINIMUM CHARGE

The minimum monthly charge shall be the highest of the net calculated bill or the following, as determined for the Member in question:

- 1. The monthly charge or
- 2. The demand charge or
- 3. Calculated based on installed transformer capacity at \$22.50 for the first 15 kVA of capacity plus \$0.85 for each additional kVA for (three-phase Members) or
