# DRIVE-THRU FUN BACK FOR '21

It's hard to believe that it has already been a year since we took a big leap into the unknown with our first ever drive-thru REC Day.

With the uncertainty that was taking place in the world, planning what was—at the time—a completely different type of event for our organization was not without its concerns. The only thing we knew for certain was that our members would appreciate both the safety and convenience of a drive-thru-style annual meeting at a location closer to home.

The outcome should not have surprised any of us. Our members responded in record numbers, shattering our previous Annual Meeting registration totals. We had 2,535 cooperative members register last year, eclipsing the previous high of 2,430 set back in 2002.

Safety and convenience continue to be our focus as we prepare for our 83rd Annual Meeting. We will once again be hosting a drive-thru REC Day this year. No longer is it a venture into the unknown. We spoke to many of you following last year's meeting and know you appreciated the ease of the modified format. Our Board of Trustees listened, so on Saturday, September 18, 2021, we will be bringing REC Day back to a town near you. The drive-thru format will once again allow members to register, vote, and receive a gift without ever leaving their vehicle.

You can register between the hours of 8 a.m. and 12 p.m. at one of four designated registration sites. The location you choose does not have to be the one closest to your home or business. Keep in mind you will only be able to register once. Once you have registered, you will not be able to register again at another location.



# ANNUAL MEETING MINUTES .....

# **SEPTEMBER 19, 2020**

The 82nd Northeast Oklahoma Electric Cooperative, Inc. (hereinafter "Cooperative") Annual Membership (Business) Meeting was held through remote broadcast from the Cooperative's Headquarters in Vinita, Oklahoma, on Saturday, September 19, 2020.

President Dandy Risman called the meeting to order at 3:00 p.m. and announced that a quorum of members, 2535, had registered. Lindey Leforce delivered an invocation, which was immediately followed by the pledge of allegiance led by various Cooperative employees. President Risman continued by reading the official meeting notice mailed to the members in accordance with the Bylaws. President Risman addressed the 2019 Annual Meeting minutes previously distributed to the membership. President Risman asked if there was a request to read the 2019 Annual Member Meeting minutes. Hearing no such request, the reading of the minutes was omitted. There were no corrections to the 2019 Annual Meeting minutes and the minutes stood approved as written.

The 2019 Cooperative Report and Year in Review was presented.

Before announcing the voting results regarding the proposed Bylaw Amendments, Legal Counsel (Logan & Lowry, LLP) introduced the Credentials and Election Committee ("C&E").

# **2020 VOTING RESULTS WERE AS FOLLOWS**

Counsel announced that the C&E Committee had certified the Bylaw Amendment votes. The voting results were as follows:

Out of 2511 ballots cast:

- 2331 ballots cast "FOR" (in favor of) the Bylaw Amendments
- 180 ballots cast "AGAINST" the Bylaw Amendments.

Counsel announced that the Bylaw Amendments passed. General Manager, Daniel Webster, oversaw the prize drawings.

Seeing no unfinished or new business, Mr. Webster entertained a motion to adjourn the business meeting. A motion was made by John Myers and seconded by Charles Wyrick. The motion carried and the meeting adjourned at 3:12 p.m.

# **NOTICE** REQUIREMENT TO REGISTER AT ANNUAL MEETING:

In accordance with Article II of Northeast Oklahoma Electric Cooperative, Inc.'s Bylaws, only eligible members may register and cast a ballot at the Annual Member Meeting. In order to register and vote you <u>MUST</u> be one of the following:

- Primary on an individual account
- Primary or secondary on a joint account (only one joint member may vote)
- Named representative of a business or organization (present the completed voting delegate form, available on our website at: noec.coop/memberservices/form-downloads/).

If you are not listed on the account, regardless of marital status, or are a suspended member, you will <u>NOT</u> be able to register and vote. We strongly encourage you to check your account. It is simple to add a person to make a joint account. Call member services at 918.256.6405.

# NOEC BOARD APPROVES 2020 PATRONAGE ALLOCATION

Cooperative businesses are unique. They are owned by the members they serve and are guided by a set of seven principles that reflect the interests of those members. One of those seven guiding principles is Member Economic Participation.

Economic participation simply means that members contribute equitably to-and democratically controlthe capital of the cooperative. Unlike investor-owned utilities, cooperatives do not issue stocks. Surpluses are margins, not profits.

Margins exceeding what is required to operate are allocated to member patronage accounts. The success of a cooperative is shared with its members through annual patronage allocation.

Northeast Oklahoma Electric Cooperative's Board of Trustees recently approved allocation of 2020 patronage capital totaling \$5,153,055.

For 2020 usage, an allocation factor of \$.007866 per kilowatt-hour (kWh) will be used. A member using 1,389 kWh per month, for example, would produce \$131.11 in patronage.

To calculate the amount allocated to your member patronage account for 2020, simply multiply the allocation factor of \$0.007866 by your total kWh of usage for the year.

If you are a member of the cooperative with active service, you can find the allocation amount in the upper right-hand corner of your September 2021 statement. This amount will remain in your patronage capital account until a future patronage retirement is made.

# CAPITAL CREDIT RETIREMENT AUTHORIZED

Northeast Oklahoma Electric Cooperative's Board of Trustees recently authorized the distribution of \$1,217,629 in capital credits. Capital credit represents member equity in the cooperative.

Current and former members who received electric service from the cooperative in 1988, 1989, and 2020 are eligible for a retirement. Checks will be mailed to eligible members in September 2021 for their portion of the credit retired. Amounts totaling less than \$10 will roll over to future years and a check will be issued after a minimum amount of \$10 is reached.

Electric cooperatives create ownership for members by allowing them to share in the success of the business. Unlike other utilities, your cooperative exists to make sure your needs are met-not to make a profit. As a member-owner, you share in these profits in the form of capital credit refunds.

The cooperative works hard to keep rates low, and profit (or margins) go back to you-the member/ owner. Rates are set at a level necessary to pay operating costs, make payments on loans, and provide an emergency reserve. Operating costs are subtracted from the total amount collected during the year. The balance is margins. Margins are allocated based on kWh usage.

Before distributing the capital credit, NOEC's Board of Trustees first considers the financial condition of the cooperative, the need for capital funds, and the availability of loan funds. The board is honored to serve you and to have the opportunity to share the cooperative's success with you because our success is your success.

# **DISTRICT MEETINGS COMPLETE**

Five individuals, including two incumbent trustees, filed for candidacy for the Northeast Oklahoma Electric Cooperative Board of Trustees during the designated filing period of July 5-9, 2021.

Section 3.06 of the organizational bylaws requires any member to file with the cooperative their notice of candidacy. Only pre-qualified candidates can be nominated at district meetings.

Incumbent trustees filing in 2021 for another three-year term on the cooperative board included: John Myers (District 4) of Vinita and Sharron Gay (District 6) of Adair.

Joining the two incumbents in filing for candidacy during the designated filing period were cooperative members Lana Daugherty (District 4) of Vinita, Mickey Tyrrell (District 4) of Vinita, and Nancy Kimbrell (District 8) of Oaks.

### **District Meetings Produce Three Trustee Candidates**

Northeast Oklahoma Electric Cooperative's district meetings produced three candidates for the office of Board Trustee. Meeting agendas weren't strictly business, however, as members in attendance enjoyed complimentary beverages, freebies, and an opportunity to win a combined \$1,200 in electric credit prize drawings.

### **District 8**

The District 8 meeting was held July 26 at the Northeast Technology Center Kansas campus with 19 registered members in attendance. Nancy Kimbrell received a nomination for the vacant District 8 seat. The District 8 seat has been vacant since the April 12, 2021, passing of Nancy's father, Bill Kimbrell. Bill served cooperative members in District 8 for 34 years.

Electric credit drawing winners at the District 8 meeting included Stanley Wolfram (\$250) of Siloam Springs, Arkansas; Tom McClary (\$100), and Mark Hendren (\$50) of Colcord.

## **District 6**

Incumbent trustee Sharron Gay hosted the District 6 meeting July 27 at Adair Public Schools. Gay was unopposed in her bid for another three-year term on the cooperative board. Since quorum requirements were not met–only 14 members registered for the meeting–Gay will serve another three-year term automatically and won't appear on the REC Day ballot in September. Gay has served NOEC members in District 6 for eleven years.

Maxine Harris was the winner of the \$250 grand prize electric credit at the District 6 meeting, while Jack Kinion took home the \$100 credit. A third credit of \$50 went to Debbie Bailey. Harris, Kinion, and Bailey are all residents of Adair.

## **District 4**

The District 4 meeting saw three members receiving nominations, including incumbent John Myers and challengers Lana Daugherty and Mickey Tyrrell. The meeting was held July 29 at First United Methodist Church in Vinita. A total of 67 members were present at the meeting.

With three individuals receiving nominations, a vote was held to decide which two candidates would appear on the ballot at the REC Day general election on September 18. Myers received 35 votes, Daugherty 18, and Tyrrell 12.



#### **Bylaws Regarding Election of Trustees and Voting:**

#### SECTION 3.03. Election

At each Annual Member Meeting, Members shall elect Trustees by secret written or secret electronic ballot; PROVIDED, when the number of nominees does not exceed the number of Trustees to be elected from a particular Trustee District, and if there is no objection, secret written or electronic balloting may be dispensed with for that particular election and voting may be conducted in any other manner. The candidates receiving the highest number of valid votes cast shall be elected. If Trustee Candidates from any District receive the same number of votes (tie votes), the winner shall be determined by drawing of lots.

#### SECTION 3.07.

#### Voting for Trustees; Validity of Board Action

In the election of Trustees, each Member shall be entitled to vote for one (1) candidate from or with respect to each of the Trustee Districts from which Trustees are to be elected. Ballots marked in violation of the foregoing restriction shall be invalid and shall not be counted with respect to the affected Trustee District. Notwithstanding the provisions contained in this Section and in Section 3.06, failure to comply with any such provisions shall not affect in any manner whatsoever the validity of any action taken by the Board after the election of Trustees.

# **PRESIDENT'S REPORT**


I know I'm partial, but the resilience of NOEC never ceases to amaze me. These folks work hard on behalf of our membership and 2020 was no exception. Every department of the co-op once again found itself weathering a constant barrage of COVID-19

concerns in order to meet the growing demands of our busy utility.

Cooperative management deserves a pat on the back as well for the way they handled these unique circumstances. Remaining flexible while juggling fluctuating attendance, COVID testing, adherence to regulation, quarantines, virtual meetings, etc., was no small task.

I have taken a moment here to highlight a few departmental achievements you might find noteworthy when looking back on 2020. I hope you value these accomplishments, bearing in mind the challenges faced during the last year. Our employees have willingly adapted to this new climate in order to continue to serve you.

With many NOEC employees working from home during the COVID pandemic, our facilities group utilized this time wisely to perform some needed upgrades to our headquarters building in Vinita. We have already seen improved workflow as a result of these upgrades.





Adaptability was the name of the game at NOEC in 2020. Our telephone system changed to allow our employees to work from home due to the pandemic.

An astounding 119,737 calls were received in 2020 with an average call response time of two minutes and 54 seconds.

A new 10-year, long-range work plan, as well as four-year construction work plan, was developed to prepare for system growth and demand.

Crews constructed 699 new services and changed out 964 poles. Contract crews changed out another 182 poles and 17,641 meters system-wide. More than eight miles of single-phase was converted to threephase as part of planned system improvements.

- Poles Inspected: 9,872
- Poles Rejected: 787
- Rejection Rate: 7.98%
- Maintenance Items Identified: 909 (including damaged/loose hardware, insulators, etc.)
- Net Meters System-wide: 102





Thanks to a restructured vegetation management plan, we continued to see a steady decline in treerelated outages in 2020. Right-of-way crews cleared 253.74 more line-miles systemwide in 2020 than were cleared the previous year.

Thank you to the public relations team for planning and organizing the new REC Day drive-thru format, this event had record breaking attendance. NOEC also received national recognition for its work on our member publication *Northeast Connection* as well as our brand manual. We're certainly proud of these honors.

Under normal circumstances, we proudly award four \$1,000 scholarships to local high school seniors whose sights are set on furthering their education. However, with the cancellation of last year's Youth Tour trip to Washington, D.C., we were happy to be able to extend \$1,000 scholarships to our four essay contest winners as well.

Our subsidiary BOLT FIber Optic Services constructed 2,506 new service drops with help from contract crews. An additional 65 miles of new overhead fiber was constructed over the course of 2020, as well as six miles of new underground facilities.



Operation Round Up, the benevolent arm of Northeast Oklahoma Electric Cooperative and its membership continued reaching into surrounding communities with much-needed grant funding in 2020.

A total of \$109,887.56 in grant funding was awarded to 38 worthy causes.



Regardless of the obstacles or challenges a year may hand us, we will continue to step up and overcome. Dedication to you, the members, and owners of NOEC is why we continue to improvise, adapt, and overcome.

# **ANNUAL REPORT** 2020 | 2019

The NOEC Financial Services team is pleased to report another successful year in 2020. Patronage capital, or margins, totaled \$4,870,518 for the year and the cooperative finished the year in compliance with all lender guidelines. NOEC's net utility plant increased 3.4 percent during 2020 and kWh sales were flat compared to 2019. The certified public accounting firm of Eide Bailly, LLP, prepared the 2020 audit. Statements are available for review at NOEC headquarters in Vinita.
